MEMORANDUM OF UNDERSTANDING

between

International humanitarian university

Odesa, Ukraine

and

Instituto Europeu de Estudos Superiores,

Fafe, Portugal

This Memorandum of Understanding is entered into by International humanitarian university and Instituto Europeu de Estudos Superiores. Following the discussion between the Rector of International humanitarian university and the President of Instituto Europeu de Estudos Superiores both universities agree to collaborate in promoting and improving academic cooperation in research, event organization and staff/student exchange in the fields of mutual interest through appropriate means.

ARTICLE I

The parties agree on following education cooperation areas:

- Development and implementation of joint and/or double degree programmes,
- Development and implementation of joint training programmes,
- Development and implementation of joint distance/online programmes,
- Development and implementation of joint certificate programmes,
- Exchanging academic information and materials,
- Exchanging experiences and know-how on teaching methods.

ARTICLE II

The parties agree on research cooperation in the following areas:

- Performing and coordination of joint research projects,
- Providing post-doctoral research opportunities,
- Exchanging scientific and technical information,
- Exchanging scientific results in defined subject areas,
- Publishing the results in these areas.

ARTICLE III

The parties agree on scientific cooperation in the following areas:

- Organisation of joint conferences, workshops, seminars (including via Internet),
- Exchanging information about conferences and workshops.

ARTICLE IV

The parties agree on cooperation in staff and student exchange in the following areas:

- Exchanging students, faculty and administrators for educational/training purposes for a predefined period
- Enabling students to take up MSc, PhD or postgraduate studies at a partner institution,
- Exchanging students to carry out a specific project, practical training or to prepare a thesis,
- Exchanging staff to carry out a specific project, practical training and/or to attend a thesis defence,
- Exchanging students under student traineeship schemes.

ARTICLE V

This Memorandum of Understanding shall be effective for a period of 5 (five) years from the date of signing unless one of the parties notifies the other in writing to terminate the agreement no later than 6 (six) months to the termination of the agreement. However, the agreement may be amended by the mutual consent of both universities. Unless otherwise stated this agreement may be extended to another 5 (five) year period with the written agreement of both parties.

This agreement shall be made in English and be validated by the signing of both copies by the authorized representatives of both universities. Original signed copies in English shall be retained by both institutions.

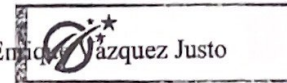
